

**CONCLUSIONS OF THE REVISION COMMISSION


Based on the results of this examination, the Revision Commission came to the following conclusions:


1. The financial and business transactions of PJSC MMC Norilsk Nickel are recorded in compliance with the approved accounting policy of the Company.

The examination did not reveal any facts of misrepresentation in the accounting statements, consolidated financial statements, non-observance of legislation or regulatory acts, which could threaten the reliability and liquidity of PJSC MMC Norilsk Nickel and infringe the interests of its investors or shareholders.
3. In the opinion of the Revision Commission, information included in the annual accounting statements, consolidated financial statements and annual report of PJSC MMC Norilsk Nickel is reliable.
4. The results of the Company performance in 2017 as reflected in the annual report, consolidated financial statements and annual accounting statements, including profit-and-loss statement, are recommended for the review and further approval by the General Meeting of the Shareholders.


